

February 2024: Final Rule updated 42 CFR Part 2 to improve care coordination while maintaining privacy protections

Key Changes		
Single consent now covers all future uses	HIPAA-covered entities and business	
and disclosures for treatment, payment,	associates can redisclose records following	
and healthcare operations (TPO).	HIPAA guidelines	





Key Features

Patients now only have one option of sharing SUD data

- Expiration date can be set to "does not expire", however can revoke consent at anytime
- Managed Care Organizations can submit a beneficiary's
 consent to share SUD data through the HIE and view SUD data in the HIE

Integrate Consenting into Your Workflow

Front Desk/Intake Process

Patient Checks-In

Staff explains consent process gives patient option to share their 42 CFR Part 2 data through the HIE



Patient signs consent form to share their 42 CFR Part 2 data through the HIE

Provider is notified of consent registration for release of 42 CFR Part 2 data in the HIE



Integrate Consenting into Your Workflow

Triage Process

Conduct Examination and assessment Staff discusses treatment options and explains consent process to patient

Patient signs consent form to share their 42 CFR Part 2 data through the HIE

Provider can now see data related to the patient's SUD treatment in the HIE
